## DOUBLE UP DEALING PROCEDURES

Dealing procedures for the DOUBLE UP GAME

DOUBLE UP uses the IDEAL shuffle machine (Shuffle Master Inc.) set in DOUBLE UP mode.

Double up is played with normal 52 card deck card values are the same as blackjack except aces always total 1.

The hand starts with each player making a mandatory BET on their bet icon. Each player may also make an optional RED/BLACK b t in an amount equal to or less than their mandatory bet.

After all bets have been placed the dealer takes the FOUR cards from the well of the shuffle machine and spreads them from right to left face down over the card outlines on the table layout

Starting to the right the dealer now turns the first three cards, one at a time, face up on the table.

The dealer now announces the total of the three open cards and the winning color. The winning color is determined in the following way:

If two or more of the open cards are RED then red is the winning color, likewise if two or more of the open cards are BLACK then black wins. The dealer now collects all losing RED/ BLACK bets, and then pays winning RED/ BLACK bets at even money and pushes both the original bet and the winnings back to the player.

At this point the dealer gives the players the opportunity to place the DOUBLE UP bet by passing their hand across the layout at the 40 bonus line from Left to Right (in a motion similar to asking for insurance) announces DOUBLE UP bets then Right to Left closing the bet,

After the players have acted the dealer will turn the forth card face up and announce the four card total. With totals 4 to 19 and 31 to 39 the dealer pays all bets even money .On the bonus 40 total all bets are paid 2 to 1.

Totals 20 to 30 including 20 and 30 the players lose all bets in action. The dealer now returns the four cards to the shuffler and a new game will began. When the three card count is 19 or 20 the dealer will announce the black or red outcome then announce it HOUSE HAND before taking all losing player bets. The forth card will then be exposed.

When a shuffler is not available the procedure will be, hand shuffle (following the casino's procedures. Then using a cut card offer a cut to a random player, the dealer now BURNS one card and starting to the dealer's right place one card face down on each of the first three card outlines.

Starting from the right the dealer now turns each of the three cards face up and announces the three total and the wining color, then works the color bets as described above, then calls for DOUBLE UP bets. After all players have acted the dealer will

BURN one card and place the final card face down on the forth card outline. The dealer now turns the forth card face up and announces four card total and works the payouts as outlined above. When all action is complete the dealer will take the four cards and lace them back into the deck and a new hand will began.
